

QUESTION 4 (20 marks)

a) There are several elements of a partnership. Examine the following situations and decide whether the following parties are partner. Explain reasons for your answers.

i. Yusuf and Yunus shared their money to buy a shophouse. The shophouse is rented and the rental derived from the shophouse is shared between them.

ii. Rahman owns a taxi but the taxi is driven by Rahim. Every month, Rahman receives money for the rent of his vehicle and Rahim is paid wages for his work.

iii. Sally lends RM 10 000 to Susi and Riri who intend to operate a chain of burger stalls. Sally enters into a written contract with Susi and Riri. They agreed that Susi will be repaid RM 10 000 together with 15 per cent interest. Is Sally a partner to Susi and Riri?

iv. Pak Lan is a salesman for Life Magazine Sdn Bhd. He is paid 5 percent of the profits the company makes out of magazines sold by him.

b) Yazid, Zul and Zaidi formed a partnership operating a clinic. Yazid and Zul were active partners while Zaidi was a sleeping partner.

One day, after involved in a road accident, Susanti went to the clinic and received treatment from Yazid. Susanti told Yazid about the road accident. Yazid suggested Susanti to take a legal action. Susanti then took a legal action as advised.

Later, the Court ordered her to pay certain amount of money against Defendant of the case. Susanti claimed that the clinic has given a wrong legal advice and she wanted to sue Yazid, Zul and Zaidi. Advice Susanti.
