#### QUESTION 1.

Mimi and Mama are partners of a HeavyMetal Hair Beauty Saloon. Mama has been expressly prohibited from entering into any contract on behalf of the partnership. When Mimi went overseas for her holiday, the Saloon's air-conditioner broke down and caused their customers to complain. In her desire to ensure their customer's continuous comfort, Mama made an effort to repair the air-conditioner, but was told by the repairman to buy a new one as the damaged unit was an old model and was beyond repairs. Mama then consulted Musa, an air-conditioner supplier and he recommended that she purchase a new industrial unit that was more suitable for the Saloon at a price of RM10,000-00 inclusive of installations. Acting on Musa recommendation, Mama purchased and installed one industrial unit air-conditioner at the Saloon.

When Mimi returned from her holiday, she refused to pay Musa for the air-conditioner as she felt it was too expensive.

Advise as to whether Musa has any right against the partnership for the payment and support your answer with relevant provision of the Partnership Act 1961 and relevant decided cases.
