Question 3

Call to open PAC proceedings to the public

The Public Accounts Committee (PAC) proceedings should be made open to the public, say the committee's newly appointed chairman and vice-chairman. Chairman Datuk Mas Ermieyati Shamsuddin and vice-chairman Wong Shu Qi urged Dewan Rakyat Speaker, Datuk Johari Abdul, who is Chairman of the Standing Order Committee, to make the amendment to Standing Order 85 of the Dewan Rakyat.

"We believed PAC hearings should be held openly to ensure all proceedings are held in a transparent manner with accountability and credibility in line with institutional reforms which is the main focus of the current government," they said in a joint statement. They said their first task would be to visit the Bousted Heavy Industry Corp (BHIC) shipyard in Lumut, Perak to find the progress of the Royal Malaysian Navy's Littoral Combat Ship (LCS) project. Which should be reported on a quarterly basis.

Mas Ermiyati and Wong also plan to meet soon with all ex-officio members of PAC from the Finance Ministry, Economy Ministry, Attorneys General's Chambers, Public Service Department, National Audit Department, Accountant General's Department and Malaysian Anti Corruption Comission (MACC) to discuss the direction of PAC and related matters.

The appointment of Masjid Tanah MP Mas Ermieyati and Kluang MP Wong to PAC on the 15th Parliment were approved by the Dewan Rakyat via voice vote yesterday after the Prime Minister Datuk Seri Anwar Ibrahim tabled a motion on them. Mas Ermieyati is the second women to Chair the PAC after Datuk Seri Noraini Ahmad in April 2019.

The PAC normally includes six to twelve members whom a selection committee nominates. It has a Westminister parlimentary system for scrutinizing the findings of public audits. The PAC can also call up ministers, the public civil service and other officials for questioning, before the committee. The Dewan Rakyat aslo announced the 10 bipartisan special select commitees, consisting of nine members, to serve as better check and balance on the government.

According to the blue bill for the MPs, Finance and Economy will be chaired by the former deputy finance minister and Paya Besar MP Datuk Mohd Shahar Abdullah; Health (former health minister and Kuala Selangor MP Datuk Seri Dr Dzulkefly Ahmad) as well as Entrepreneurship, Cost of Living and Agriculture (Rasah MP Cha Kee Chin). Infrastructure, Transport and Communications is chaired by Tanjong Manis MP Yusuf Abu Wahad; Women,

Children and Community Development (Bakri MP Yeo Bee Yin); Security (Ranau MP Datuk Jonathan Yasin) as well as International Relations and International Trade (Subang MP Wong Chen).

Human Rights, Elections and Instituitional Reforms will be headed by Kota Melaka MP Khoo Poay Tiong; Environment, Science and Agriculture chaired by Sandakan MP Vivian Wong and National Building and Education & Human Resource Development chaired by Jempol MP Datuk Shamsulkahar Mohd Deli.
