Shipping documents are those forms needed to take delivery of a shipment, or for a delivery for customs clearance. These documents are needed in order to bring a shipment into compliance with the regulations of the countries through which it travels. It is an official records issued during the shipping process, containing important information about the goods being transported, the parties involved, and the terms and conditions of the shipment. One of the most important document is Bill of Lading.

- a) Interpret the FOUR (4) main functions of Bill of Lading in shipping business. (10 marks)
- b) When a merchant or shipper loaded the cargo on board a ship, the captain will sign the Bill of Lading to show it has been shipped on board. Find the important information stated in Bill of Lading document. (10 marks)

Question 2

Transporting goods through seaborne vessels has become one of the cheapest means of transportation, from machinery and equipment to foodstuff and vehicles. Ships are modified to handle various types of goods. Crude oil, fuel gases such as LNG and CNG, minerals, and ores require their own types of vessels that are specially constructed to cope with the increasing demand.

Question 3

Managing Liner shipping company are more complex compared to the Tramp company. This involves overseeing the operations of a business that provides scheduled maritime transportation services for cargo, particularly containerized goods, across fixed routes and timetables. Unlike tramp shipping (which operates on demand), liner shipping functions similarly to public transport systems, with published schedules, regular ports of call, and fixed routes.
